

GEORGIA, DOUGLAS COUNTY.

I Mrs. Jennie Hellis of said State, and County, being of sound and disposing mind and memory, do make this my last Will and Testament, hereby revoking and annulling all others, by me heretofore made.

1st. I desire and direct that my body be buried in a decent and Christian like manner suitable to my circumstances and conditions in life.

2nd. I desire and direct that all my just debts be paid without unnecessary delay, by my Executors hereinafter named and appointed.

3rd. I will bequeath and devise all of my property both real and personal of whatever kind and wherever situated, to my (Four) beloved children Mrs. Edessa Hellis Darnell, T.P. Hellis, R.P. Hellis and J.E. Hellis for their use, and benefit for and during their natural life, and they have the right to sell, dispose of and do anything in reference thereto that they may deem proper, without any order of court, and without the consent, control or interference with them by any other person.

4th. Provided they, my four children do pay to my beloved husband and Father of the said four children J.W. Hellis sixty Dollars each, per year making a total of Two Hundred and Forty Dollars, for each year as long as he lives or remains single.

5th. It is my will and desire and I do intend that the provided made in Item (4) of this will for my husband and the stipulating made to him shall be in lieu of a child's interest allowed by law as an heir of an estate.

6th. I hereby name and appoint my two eldest children, Mrs. Edessa Hellis Darnell and T.P. Hellis, as Executrix and Executor of my will and I hereby expressly relieve them of giving and bond, and all that is required of them is to perbate the same. And then enter upon and take charge of all my property, as provided and proceed to carry out the provisions of this my last will and testament. This the 7th. day of Aug. 1921.
