## JEFFERSON HOWARD LAND.

I, Jefferson Howard Land, of said State and County, and City of Austell, being of sound and disposing mind and memory, do make this, my last Will and Testament, hereby revoking all Wills heretofore made by me.

Item I. I hereby direct my executrix, hereinafter named, as soon after my death, as possible, to pay my debts. If a sale of property shall be necessary, I wish her to select for sale that which can be most advantageously used for that purpose, and I authorize her to sell the same at public or private sale, as she may see fit.

Item II. It is my wish and desire that my body be given a simple, Christian-like burial, and that the marking of my grave be modest and not of such a character as to embarrass my wife in any manner, shape or form.

Item III. I give and bequeath to my son, Thomas Jefferson Land, Five (\$5.00) Dollars in cash, having already given his five Hundred (\$500.00) Dollars in cash as his portion of my property.

Item IV. I give and bequeath to my daughter, Candice Elia Mass, Five (\$5.00) Dollars, having previously given her Five Hundred (\$500.00) Dollars, being her portion of my property.

Item V. I give and bequeath to my wife, Caroline March Land, all of the property, of which I may die seized and possessed, both real and personal, of every character whatsoever, and wherever situated to be hers forever, feeling confident that she will mete out justice to our three sons, heirs of her leg, and maintain and educate them to the best of her ability, in proportionate with her resources.

Item VI. I do hereby appoint my beloved wife, Caroline March Land, executrix of this, my last Will and Testament, and hereby relieve her from giving or making returns to the Court of Ordinary.
