Last Will and Testament of M.J.Turner.
 I, M.J.Turner, of said State and County, being of sound and disposing mind and memory, do make this my last will and testament, hereby revoking all wills heretofore made by me.

Item 1; I wish my executor as soon as possible after my death, to pay my debt and to put a suitable marking to my grave and pay for it; If a sale of property shall be necessary, I wish him to select that which can be most advantageously used for that purpose, and I authorize him to sell the same at public or private sale, as he may see fit.

Item 2: I wish my executor to divide equally between my children living at the time of my death my clothing, bedding, pictures, books, jewelry, and household and kitchen furniture except the organ, preferably by letting each select articles they desire, but in the event that any difference may arise between them, then my executor is to make the division equitably between them to the best of his judgment.

Item 3; All the remainder of my estate, both real and personal including the organ, I wish my executor within twelve months after my death, to turn into cash by selling either at public or private sale as he may deem most advantageous.

Item 4: After paying the expenses of winding up my estate out of the funds raised as mentioned above in item three, I will that one hundred dollars be paid my son Marcus and also one hundred dollars be paid my daughter Jessie in recognition of their love and tender care of their mother and myself in our latter days, this is to be extra of their regular shares.

Item 5; After paying the amounts mentioned in Items One and Four mentioned above, I will that all the remainder of my estate be divided equally between my children named as follows; Peter, Jim, John, Marcus, Jessie and the children of my deceased daughter Lula to share equally the share of their mother.

Item 6. I do hereby appoint my executor of this my will and testament and especially relieve him from giving bond or making inventory or making returns.

In testimony whereof, I have hereunto set my hand this day of 1923.
