I, M.W.Daniell, of said State and County, being of sound and disposing mind and memory, do make this my last will and Testament, hereby revoking all Wills heretofore made by me.

Item 1. I give and bequeath to my beloved Son J.C.Daniell the following property to-wit: my large wooden bedstead, 1 wire bed, 1 feather bed, 4 quilts, 2 pillows, 2 sheets, 1 dresser, 1 washstand, 1 wardrobe, 1 large & 1 small trunk, the trunks belonging to myself and wife during her lifetime, 1 rocking chair, 1 plain chair, 1 double leaf table and the Bible thereon, 1 iron bedstead. Also all the Kitchen utensils and furniture of every kind and description, 1 Mattress and 1 set bedsprings.

I also give and bequeath to my Son J.C.Daniell all of the money, notes and accounts that I may have at the time of my death.

Item 2. I give and bequeath to my beloved sons M.R.Daniell, E.V.Daniell, D.J. Daniell and my beloved daughters Mrs. M.W.Daniell and Mrs. H.R.Aderhold all the balance of my household furniture my Sewing machine and any other property I may have at the time of my death which is not willed to my son J.C.Daniell.
