

GEORGIA, DOUGLAS COUNTY.

J. Mollie Morris of said State and County, being of sound mind and memory do make this my last Will and Testament.

Item. It is my desire and I so direct that as soon as practicable after my death, all my just debts be paid, also expenses of funeral and bills of physician.

Item 2. It is my Will and I so direct that my house and lot in the Town of Douglasville, Douglas County, Georgia, described in deed to me as follows A tract of land in the shape of a square, being 200 feet by 200 feet, lying in lot No. 21 of the 1st. Dist. & 5th. Sec. of originally Carroll now Douglas County, Georgia, beginning at a point on a line with northern boundary line of the lot of Lou Clegg but on East side of Street, thence 200 feet to corner thence North 200 feet to corner, thence West 200 feet to corner and to said Street, thence South a long said Street 200 feet to commencing point.

Also lot described as follows: being in original land lot No. 21 in the 1st Dist. and 5th. Sec. of originally Carroll but now Douglas County Georgia, and known as lot Number 25 as shown on Plat of Mrs. E.J. Quillian's lands in Town of Douglasville, Ga. made by W.J. Hally Surveyor and Civil Engineer.

Said last described lot lying South of the first described lot, be sold after my death and the proceeds paid out as follows:

1. Pay all debts and expenses as provided in the first item of this my Will.

2. The remainder divided equally among my beloved husband Sam Morris, my beloved daughter Mary Frank Simmons formerly Mary Frank Morris and my beloved son James Horace Morris share and share alike each one taking one third undivided interest.

Item 3. It is my Will and I so direct that my daughter Mary Frank Simmons shall have my suit of furniture, the other household goods and kitchen furniture I give and bequeath to my husband Sam Morris.

Item 4. I hereby Constitute and appoint My husband Sam Morris and my son James Horace Morris Executors of this my Will and I relieve them from giving bond and security.

Item 5. It is my Will and I so direct that my Executors shall have the right and power, to sell my property at either public or private sale without obtaining any order from the Court of Ordinary.
