

GEORGIA, DOUGLAS COUNTY.

I, Newton A. Hamby being of Sound and disposing mind and memory do make this my last Will and Testament.

1st. I will that my body be buried in a decent and Christian like manner suitable to my circumstances in life and that all my just debts be paid by my executors after my decease, and that my executors shall place at my grave a monument, not to exceed in cost one hundred dollars, this is to embrace one to the grave of my wife in case she survives me.

2. I give and bequeath to my beloved wife, M.E. Hamby all my property both personal and real, which I may possess at the time of my death, to be hers for and during her life, and at her death, I will that it shall be divided as follows;

A. I will and bequeath to my daughter Mary Elizabeth Grubbs one hundred dollars to be paid to her by my executors before there is any division of my estate.

B. I will and bequeath to my son James S. Hamby my ford automobile.

C. I will that at the death of my said wife, that my executors shall sell all my personal and real property, without an order from the court of Ordinary by advertising the same for thirty days in the public gazette of said county in which sheriff sales are advertised, and said sale to take place, at my late residence between the legal hours of sale after the advertising, and the money arising from said sale, except the bequests heretofore made to Mollie Elizabeth Grubbs shall be divided equally between the following children- Mrs. Laura Jones, Jeff R. Hamby, Marsh H. Hamby, Martha A. Baggett, Mollie Elizabeth Grubbs, Joseph A. Hamby and J.S. Hamby.

The automobile bequeathed to J.S. Hamby is excepted in the above deceased property, and is not to be counted in the division of my estate, but to be delivered to him, the said J.S. Hamby by my executors upon my death; Title to said Automobile shall immediately vest in the said J.S. Hamby upon my death.

4th. I nominate and appoint Jeff R. Hamby my beloved son, Executor of this my last Will and Testament, without being required to give bond for his acts and doings unless the Ordinary shall direct otherwise.
