

State of Georgia, Douglas County.

I, Annie Marcella Peale, of said State and County, being of sound and disposing mind and memory, do make this, my last Will and Testament, hereby revoking all and annulling all others by me heretofore made.

1. I desire and direct that my body be buried in a Christianlike and a decent manner, suitable to my circumstances and condition in life.

2. I desire and direct that all my just debts be paid without unnecessary delay, by my executors hereinafter named and appointed.

3. I give, bequeath and devise to my son Reubin H. Peale, my plantation consisting of 445 acres, more or less, known as the the Wright place, known as lots numbers 13 and 14 and fractional lot number 24 in the 2nd. district and 5 section of Douglas County, Georgia, I do this from a sense of justice I feel that I owe him, he having spent most of his life in aiding and helping me since his father died. He has never left me, has always been willing to help me in every way needful. I desire that he act as agent for his sister Carrie Peale, which shall share with him this gift whenever it may become necessary for her welfare. It is my desire that my son R.H. Peale and my daughter Carrie Peale enjoy this tract of land as they may see proper and as it may become necessary for their comfort and welfare, and to this end they may sell it or trade it just as they may deem proper and fit at their pleasure. I give them power to make deeds and titles to it just as they see proper with out any authority from any court whatsoever. It is my desire and Will that my said son Reubin H. Peale attend to all the business and act for and in behalf of his sister Carrie Peale. It is my desire that after the death of both, that is R.H. Peale and Carrie Peale, should both leave no heirs then it is my will that the said lands described in this item if not then already sold and used up by Reubin H. Peale and Carrie Peale or either of them, go to my living then living children and children of each of my children as may be deceased to be divided among them share and share alike. The children of such of my children as may be deceased are to receive the share only that their deceased parent would receive if alive.

4. It is my desire and will that Reubin H. Peale and Carrie A. Peale occupy the homestead for a period of three years after my death or for a longer period if it become necessary for their welfare or the welfare of either. After expiration of this period it is my desire that Reubin H. Peale and Carrie A. Peale have for themselves such furniture and household goods as they may need (from my furniture and household goods) such as bedding and necessary household articles as they may need when they arrange a home for themselves. It is my desire that they live together each caring for the other. In all matters of every nature my son Reubin H. Peale shall act as agent for his sister Carrie A. Peale and person and do every act necessary under this will for her. It is my desire and will that such furniture and household goods as my said son Reubin H. Peale and Carrie A. Peale do not need to arrange for

said note in sum of \$1410.00 as principal and interest thereon at rate of eight per cent per annum from date of said note. It is desired that said note be paid regardless of date of the same; and said debt of \$1410.00 with interest thereon at eight per cent per annum from date thereof is hereby acknowledged by me and this is to renew said debt and to revive the same.
