- 1 I desire that my body shall be buried in Christainlike manner suitable to my circumstances in life, my Soul I commend to God who gave it to me.
 - 2 I direct that my just debts if any there be at the time of my death be paid as soon as can be conveniently done.
 - 3 I direct my Executors hereinafter named to sell the Hendricks Farm to-wit; Lots 567, 568 and 569 in the 1st District and 3rd. Section of Paulding County, Ga. containing 118 acres more or less.
 - 4 It is my Will and I do so direct that my beloved Wife, Mrs. S.C. Wood have the use of the following described Real Estate for and during her natural life to-wit; House and Lot in the Town of Douglasville, Douglas County, Ga. in which I now live, which said lot fronts 100 feet on the West side of Chicago Avenue and runs back in a westerly direction 360 feet to Peat Avenue, bounded on the North at present by E.P. Rawland property by J.W. Banks and on the South by E.P. Rawland property. Also what is known as my old Home Farm in Paulding County to-wit; lots of Land Nos. 622, 623, 650, 651, containing 40 acres more or less and the West half of land lot 624, containing 20 acres, more or less, all in the 1st. District and 3rd. Section of Paulding County, Ga. and a part of lots 623, 650, 651 lying in Douglas, County, Ga. Containing in all 180 acres, more or less. For and during her natural life. Also all of my personal property consisting of Live Stock, Wagons, Buggies, Household and Kitchen Furniture and all other personal property except my notes and accounts which are to be collected by my Executors and paid out as hereinafter directed.
