

# STATE OF GEORGIA.

By His Excellency *G. M. Brown* Governor and  
Commander in Chief of the Army and Navy of this State and  
of the Militia thereof.

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING.

KNOW YE, That in pursuance of an act of the General Assembly, passed the 15th of May, 1821, for making distribution of the land lately acquired of the Creek Nation of Indians, and forming the counties of Dooly, Houston, Monroe, Fayette and Henry, in this State, I HAVE GIVEN AND GRANTED, and by these presents, in the name and behalf of this State, DO GIVE AND GRANT, unto

*Archibald Hollands of Savannah,  
District Greene County, his  
heirs and assigns foreve , all that Tract or Lot of Land, containing two hundred two and  
a half acres, situate, lying and being in the Fourteenth  
district of ~~Selby~~ county, in the said State, which said  
Tract or Lot of Land is known and distinguished in the plan of said district by the Number  
~~Eighty two~~ having such shape,  
form and marks as appear by a plat of the same hereto annexed : To have and to hold  
the said tract or lot of land, together with all and singular the rights, members and ap-  
partenances thereof, whatsoever, unto the said *Archibald Hollands*  
and his heirs and assigns ; to his and their proper use, benefit  
and behoof forever in fee simple.*

GIVEN under my hand and the Great Seal of the State, this 23rd  
day of December in the year of our Lord eighteen hundred and  
thirty six and of the ~~forty~~ *fifty* ~~four~~ *four* ~~threet~~ year of American
