and being of sound mind and memory do make
this my last will and Testament

First I give and bequeath to my Grand son
Richard Bartons a negro man slave named
Cassius

Second I give and bequeath to my Grand son
George Bartons a negro boy slave named
John

Thirdly I give and bequeath to my son
George Bartons in trust for my Grand daughter
Mary H. Brown the land and the heirs of
her body a negro Woman slave named Ciza
and her increase

Fourthly I give and bequeath to my son
John or Bartons in trust for my Grand daughter
James Ransom Wife of H. R. Ransom and the heirs
of her body a negro Woman slave named Hannah
and her increase

Fifthly I give and bequeath to my son George
Bartons in trust for my Grand daughter Mary
Bartons and the heirs of her body a negro boy
slave named George

Sixthly I give and bequeath to my son
George Bartons in trust for my Grand son
daughter Elizabeth Bartons and the heirs of
her body a negro boy slave named Robert

Seventhly I give and bequeath to my Grand son
William J. Bartons son of George Bartons
a negro boy slave named Charles

Eighthly I give and bequeath to my son George
Bartons son of George Bartons a negro boy slave
named Jadge

Ninthly I give and bequeath to my daughter in law
Polly Bartons wife of my son George Bartons a negro
boy slave named Andrew to have and possess during
her natural life and at her death it is my will
and I desire that she shall have the privilege of
designating or appointing to which one or more of my
Grand children the heirs of her body and myself
George and her issue shall succeed

Tenthly I give and bequeath to my daughter
Lucy A. left to Henry George and Henry Ransom
each the sum of Five dollars having been seen given
to them and into their possession and enjoyment what
I consider their and each of their full proportion
and share of all my worldly effects

Eleventh I give and bequeath to my son George
Bartons and his heirs into his possession and full enjoy-
ment the following real estate negro slaves to wit:
a negro fellow named Bell, a negro fellow named
Keston a negro boy named Tom a negro woman
named Miller a negro woman named Emily and
a negro boy child named Sampson

Twelfth I do hereby appoint my son George
Bartons and my Grand son Richard Bartons my
Executors to carry into effect this my last Will and
Testament

In testimony whereof I have hereunto set
my hand and affixed my seal this 16th day of August
in the year of our Lord one thousand eight hundred
and forty two
