 of every description and Character, all moneys,
 Notes and accounts, and Chases in action

 Character, free from all Charge and Incumbrance
 signature to the Ours use, benefit and behoof
 for as in full simple with full Power to
 dispose of the Same by will or otherwise
 as she may deem fit and proper. I also
 give and bequeath to my said wife in
 the same preserving manner all my
 household and kitchen furniture of every sort
 whatsoever.

Item 4

I hereby constitute and appoint my wife Mrs.
 E. C. Thacker Executor and my Son W. B. Thacker
 Executor of this my Last will and Testament
 and I expressly Confess upon them Power as
 such Executors and Executor to administer my
 estate choosing them from giving any bond
 or making any return to the Orphans Court and I
 expressly Confess upon them the full Power
 to sell any Part of my Estate now hereinafter
 specially devised at Public or Private Sale
 with or without notice as they may deem
 best and without any Order of Court.
