

Last will and Testament of
Chasmy M. Carley

I Chasmy M. Carley of Rockdale County, being of sound and disposing mind and memory do make this my Last will and Testament hereby revoking all wills heretofore made by me.

- Item 1 I wish my body to be buried in a manner suitable to my condition and standing in Life.
- Item 2 I wish my just debt to be Paid as soon as the same can be done without sacrifice to my Estate.
- Item 3 It is my Will that my minor children be to school during the full School Term each year as long as they are eligible +
- Item 4 It is my Will and I direct that None of the Beneficiaries under my Will as set forth below shall sell, waste or otherwise dispose of their Legacy before they come in possession of it after my death.
- Item 5 It is my Will and I do direct that my Estate both real and Personal remain in Trust and managed by my Executors as hereinafter named by me, and that the Net Proceeds said Trust be Paid for the Support of my Wife and minor Children and for the Support and Education of my minor Children during the Life of my said wife or as long as she remains my Widow, and until my youngest Child is Twenty one (21) years old. If there is any thing remaining after providing for my said wife and minor Children, and Expenses I direct that it be Placed in some Good Safe Bank, from Year to Year when there is an Overplus, at as good rate of interest as can be obtained and there to remain as Part of my Estate during the Life of this will. Provided it does not from some Cause become necessary to use it - or any Part of it for the Purpose aforesaid set forth for the Support of my said wife and minor Children - and for the necessary Expenses pertaining to my Estate. Then I direct that it may be used or sold a Portion of it as it may be necessary for these Purposes.

Item 6 When this my will has fully served the
 purpose upon it forth to wit. When my
 youngest child has attained the age of twenty
 years and my wife to be my executor of
 said will and as soon as I can I will
 be content to an other man. Then I will
 be remissive of all debts both real and personal
 that my agents or all hands both together with what
 he shall and that the executor from year
 to year my wife after carrying out
 the provisions for the support of my said wife
 and minor children be equally divided be-
 tween and alone share among all of my children

 I hereby nominate Constable and appoint my
 executor said Corley and Henry
 Corley my executors of this my last will
 and Testament and I direct that they
 shall one \$1000 dollars per day for each and
 every day that either of them directs to the
 management of my estate as set forth above
 and I further direct that my executors in the
 management of my estate nor in any way whatsoever
 be allowed to involve my estate and that they
 make returns as required by law
