This then will open the field for new candidates; and cancels all bets on the former election.

VETO OF THE SILVER BILL.—The President has vetoed the Silver Bill on the ground that it provides for the coinage of silver dollars of the weight of 412 grains, to be legal tender, at their nominal value, when it is well known that their market value would only be from 90 to 92 cents as compared with the gold dollar. He would have no objection to the silver dollar as a legal tender, if made of equal commercial value with gold.

FINANCIAL CHANGE.—The Currency Committee has introduced a bill in Congress to retire the national bank currency with United States Treasury notes to be issued by the Secretary of the Treasury. If this bill passes, bank credit will rest upon coin or treasury notes instead of bonds, and the latter will doubtless afford the chief paper circulation of the country, as they will be legal tenders for many purposes, and based on the credit of the government.

The term of office shall be six years, and no President having served a full term shall be eligible for a second term.
