## GEORGIA NEWS.

The *Lawrenceville Herald*, of Wednesday, has the following:

**FATAL CASUALTY**.-- As Mr. **William Brand** was returning from Covington, on the morning of the 14th, with over 1600 pounds of guano, on an ox wagon, while going down the hill three miles from Covington, the holding back pin in the wagon tongue broke, letting the whole load on the oxen. In an effort to get out of the wagon, he was thrown under the wheels, two of which ran over him, breaking his shoulder-blade and collarbone and bruising and mangling his body to such an extent that he died in about two and a half hours afterward.

A venerable brunette dame named **Dinah Walker**, died at Augusta, aged 120 years. She leaves a son aged 70 and a daughter aged 82 years.

Mr. **M. A. Rutherford**, a highly esteemed citizen of Bainbridge, died at Apalachicola yesterday week.

**ANOTHER KILLING IN MERIWETHER**.-- We get the information that **Henry Worthy** shot **Thomas Stephenson**, son of Dr. **James Stephenson**, at Sandtown, Meriwether County, last Monday, the ball penetrating his bowles and inflicting a mortal wound, from which he cannot possibly recover. Our informant tells us that the shooting on the part of **Henry Worthy** was justifiable, as Stephenson had fired two shots at him first. It is said that **Worthy** involuntary killed a man in Talbot County before the war, by the name of Dr. Nelson; and Stephenson killed **John Massengale** since the war, and was pardoned for the offense by Bullock.

Mr. **Thomas H. Weaver**, of Rome, fell from a two story house at Kingston last Wednesday and was not dangerously hurt. The distance was 35 feet.

**William Quinn**, for forty years a citizen of Floyd County, died last Monday night, aged 82 years. Within the past month four citizens of that county, all over 70 years of age, have died.

Mrs. **Rebecca Floyd**, a widow lady, aged 50 years, was killed in Floyd County, last Thursday, by **Ebenezer Allen**.

Mr. **J. R. Welester**, for forty years a much respected citizen of Hall County, died last week.

There is a **Lamp** down in Brooks County, whose light must certainly be extinguished very soon in due regard to public safety. His name is **Aaron**, and he has just killed Mr. **Daniel Downing**, of that county. He killed a negro last summer in the same county, but the evidence was insufficient to convict him. The sooner this lamp explodes the better.
