I also give and bequeath to my beloved Child Patrick Henry, in the same increased manner all my household and Kitchen furniture and also all other property owned by me or that may hereafter be acquired or inherited by me both real and personal all without reserve or limitation

Item (4<sup>th</sup>) My Husband J. R. Day from whom I am now living separate I expressly disinherit and exclude from the benefits of my will and enjoyment of any of my property real or personal -

Item (5<sup>th</sup>) I desire that N. M. Eachus of said County act as Testamentary Guardian for my beloved Child of or said and I hereby appoint him as Guardian of the person and property of my beloved Child to receive and preserve for the benefit of my Child of or said all property and effects bequeathed and devised to him under and by this my last will and Testament

(6<sup>th</sup>) It is also my desire that my brother P. H. Hall act as executor of this will
