trust that my body be buried in a Christian bur-
iall and all expenses be immediately paid by
my Executors

Item 2^d I give and bequeath to all my children all my
Real and Personal property of every kind and
description I direct that my Executors should
cause to be made an equal division among
between my children so that all shall share with
an equal of my Estate at the time of distribution of
my Estate except when I have made advances
to my children to them of my children that I have
made advances to the Decedent making such of them
by me I direct my Executors shall deduct from
their share the sum or sums advanced to them so
as to make all share in my Estate equal both
Real and Personal I also direct that the residue
share that may be coming to the minor children
of my deceased children at the time of the distribution
of my Estate to remain in possession in hands of my
Executors and direct that my Executors pay to
such one his or her respective share as they
arrive at the age of twenty one years old or if
a girl marry pay to her the share she be
not twenty one and a boy likewise if he
should marry before he is twenty one

Item 3^d I have given to my former wife Mary Ann a separate
