Item 1st It is my will that my body be decently interred and that all my just debts be paid

Item 2^d I give to my brother Lawrence L Harcum the whole of the property that I own whether real or personal and whether in possession or in expectancy whether coming to me from my late husband's estate or derived or to be derived or inherited from any other source or person to be held by him for my daughter Anna Thomas Brown according to the following uses and limitations that is to say to & for her sole & separate use benefit & enjoyment during her natural life without being subject in any wise to the debts contract or alienation of any husband or husbands that she may hereafter marry & after her death it is my will that all the property in it contained herein bequeathed to my said daughter shall go to the child or children & representatives of children in case any should die having no representatives which she may leave at her death to be shared equally

Last Will & Testament of E A Brown continued
 there should be no payment of & A Brown continued
 my said trustee is instructed to convey the same to such
 child or children or representatives of child or children
 by a legal oporance.
 And it is further my will that if my said daughter should have
 no child or children or representatives of child or children
 living at the time of her death she shall have the power
 to dispose of the said property by will & if she should
 die without child or children or representatives of child or
 children, without having made a will, then it is my will
 that the whole of the property herein bequeathed shall go to
 and vest in my nearest blood relations & their legal represen-
