objecting. It is ordered that Lewis S.
Brown, as administrator on the Estate
of Luke S. Morgan deceased, do proceed
to sell the land and Negroes, belonging

William H. Chambliss, minor orphan of Henry Chambliss over
the age of fourteen years having appeared in Court and desired the
appointment of ~~Samuel~~ ^{John} Dannelly as his guardian. It is ordered
that letters of Guardianship of the person & property of the said William
H. Chambliss be granted to the said ~~Samuel~~ ^{John} Dannelly upon his giving
bond in the sum of Seventeen Hundred \$ with security. These were
G. L. Davis & John Harrington.

Joseph B. Chambliss, a minor orphan of Henry Chambliss over
the age of fourteen years having appeared in Court and desired the
appointment of G. L. Davis as his guardian, it was ordered that letters
of Guardianship of the person & property of the said Joseph B. be granted
to the said G. L. Davis upon his giving bond in the sum of \$1600
with John Dannelly & John Harrington securities.

Ordered that Simon Parker be appointed & he is hereby appointed
Guardian of the person & property of John Chambliss, and Sarah &
Chambliss minor & orphan children of Henry Chambliss dec'd and
that he give bond in the sum of Three Thousand two hundred
Dollars and that Joshua Jordan be his security, and that
letters of Guardianship be accordingly issued to him by the Clerk.

John H. Dampforth, Abraham G. Dampforth & Saml. J. Dampforth, minors
and orphan children of Dampforth dec'd the first over four
teen years of age, all appearing in Court and desired the appoint-
ment of George A. Minchew as their guardian, it was ordered that
he be & he is hereby appointed Guardian of the person & property of the said minors
