Item (1) I desire and direct that my body be buried
in a decent and Christianlike manner suitable to
my Circumstances and Condition my Soul I trust shall
return to rest with God who gave it as I hope
Eternal Salvation through the blessed Lord and Saviour
Jesus Christ whose Religion I have professed and
as I humbly trust enjoyed for over a year in my
beloved Primitive Church

Item (2) I desire and direct that my Executors
and Executrix have Power to sell all my Land
lying in the (4) District of Bibb Original Township
County the same being three hundred and fifty
acres more or less and known in the Plan of said
District as Lot No (68) Sixty eight also the west half
of Lot No (83) Eighty three also fifty acres off the
East half of Lot No (71) Seventy one either at
private or Public Sale as they may think best
also all of my Personal Property and all my just debts
to be paid as early as possible

Item (3) I desire that a piece of Land be purchased
for a home for my Wife Mariah M Johnson
during her natural life and then to my
Children and if there be any money left
after the purchase of said Land it
be used in purchase of such property or
thing as my Exrs may think of most being
use and comfort for the family or remain
in money

Item (4) I also desire that my interest with
Willis Wood in Six hundred acres of Land
lying in the Ocmulgee Swamp being
the Twenty eighth District of Wilkinson County
unsold until such time as my Executors
may think best

Item (5) I constitute and appoint
betwee Wife Mariah M Johnson
