Anarchy - one girl Rose - one girl Ailsay to him and his heirs
forever.

Item 5th I give and bequeath to my beloved son Jeremiah L Linneman
the following named negroes, one negro man Miller
and his wife Anny, a boy Foltard, a boy Tim to him and
his heirs forever

Item 6th I give and bequeath to Daniel & Linneman and Jeremiah L
Linneman (trustees by me appointed) for the sale and separate use
benefit and behoof of my beloved Daughter Elizabeth Smith
wife of James G Smith, the following negroes to wit: one ne-
gro man Dennis and his wife Lillie a boy Arthur and a

a girl Emily, said property to be free from the debts contracts and liabilities of her present or any future husband and if she should die leaving no child or children then the portions left her to go to and be equally divided between my two Sons Daniel A. Luman and Jeremiah L. Luman.

Item 7th I desire and direct the balance of my property to be sold and the proceeds thereof equally divided between my two Sons Daniel A. Luman and Jeremiah L. Luman and my daughter Elizabeth Smith wife of James G. Smith share and share alike. And the said Daniel A. Luman and Jeremiah L. Luman to hold all the property both real and personal, negroes and money, given in this my will to Elizabeth Smith in trust for her sole and separate use, free from the contracts & debts of her present or any future husband and if the said Elizabeth Smith wife of James G. Smith at aforesaid should die without child or children then I desire and direct said share of Elizabeth Smith wife of James G. Smith under this my will as aforesaid to be equally divided between my two Sons Daniel A. Luman and Jeremiah L. Luman share and share alike and I do hereby appoint Daniel A. Luman and Jeremiah L. Luman Trustees for my daughter Elizabeth Smith.

Item 8th I hereby constitute and appoint my beloved Sons Daniel A. Luman and Jeremiah L. Luman Executors of this my last will and testament. This 15th day of October Eighteen hundred and fifty two.
