Item 2^d I desire and direct that all my just debts be paid with-
out delay by my executors hereinafter appointed

Item 3^d I give and bequeath to my beloved son Jeremiah L. Lawrence
the Homestead and Land on which I now reside provided
he should agree to give for the same the price at which
it should be appraised and the proceeds to be equally di-
vided between my three children viz; Daniel & Lawrence
Jeremiah & Lurman ^{Elizabeth} Smith wife of James G.
Smith but in the event ^{www.georgiapioneers.com} I Lurman should not ag-
ree to take the Homestead and Land at the appraisement then
the same to be sold to the highest bidder and the proceeds
divided as above

Item 4th I give and bequeath to my beloved son Daniel L. Lawrence
the following negroes viz; one negro boy Redding and girl
Anarchy - one girl Rose - one girl Ailsy to him and his heirs
forever

Item 5th I give and bequeath to my beloved son Jeremiah L. Lawrence
the following named negroes, one negro man Miller
and his wife Fanny, a boy Pittard, a boy Tim to him and
his heirs forever

Item 6th I give and bequeath to Daniel L. Lawrence and Jeremiah L.
Lawrence (or either by me appointed) for the sole and separate use
benefit and behoof of my beloved Daughter Elizabeth Smith
wife of James G. Smith, the following negroes to wit: one ne-
gro man Dennis and his wife Fannie a boy Arthur and a

a god Emily said property to be free from the debts contracts and liabilities of her present or any future husband and if she should die leaving no child or children then the persons left to go to and be equally divided between my two Sons Daniel A. Luman and Jeremiah S. Luman.

Item 7th I desire and direct the balance of my property to be sold and the proceeds thereof equally divided between my two Sons Daniel A. Luman and Jeremiah S. Luman and my daughter Elizabeth Smith wife of James C. Smith share and share alike. And the said Daniel A. Luman and Jeremiah S. Luman to hold all the property both real and personal, negroes and money given in this my will to Elizabeth Smith in trust for her sole and separate use, free from the contracts & debts of her present or any future husband and if the said Elizabeth Smith wife of James C. Smith at aforesaid should die without child or children then I desire and direct said share of Elizabeth Smith wife of James C. Smith under this my will as aforesaid to be equally divided between my two Sons Daniel A. Luman and Jeremiah S. Luman share and share alike and I do hereby appoint Daniel A. Luman and Jeremiah S. Luman Trustees for my daughter Elizabeth Smith.

Item 8th I hereby constitute and appoint my beloved Sons Daniel A. Luman and Jeremiah S. Luman Executors of this my last will and testament. This 15th day of October Eighteen hundred and fifty two.
