do hereby declare this to be my last will and testament, -
Item It is my will that after my death, that my body
should be buried in a suitable manner according
to my standing and condition in life, It is also
my further will that all legal and just demands or
debts against me be paid as soon as conveniently
can be done -

Item Second, I give and bequeath to my beloved wife Sarah Still
a certain lot of land, with all the rights, members and
appurtenances thereto belonging, Situate lying and being
in the fourth district of originally Monroe now Butts
County, the number not recollected, on which is a two
story dwelling house and a new gin house, said lot
adjoining lands of Pleasant Glass, John Thompson, William
Johnston, and others also one good horse, two Cows & Calves
with a small lot of hogs and sheep, I also give and bequeath
to her the two following named Negroes, (viz) a boy named
John about ten years old, and a man named Walker
about forty years old, the balance of my property, I give
and bequeath to my children to be disposed of as follows,
the property to be sold and equally divided between them
so that the youngest, and those to whom I have not given
any thing may have as much as those that I have
heretofore given any thing, so that each of my children
may have an equal part of all my property including what
I have at any time during life, given to any of them -

I hereby appoint and constitute Charles W. Still and Martin P.
Still my Executors, to carry into effect this my will.
