With few exceptions, the place names used in applying for Colonial Grants, are heard no more; and it would be quite difficult to ascertain the names that are now applied to those places, in all cases. Most rivers and creeks retain the names in use at that time, but there is one exception to that rule, that being the present North River, on which the St. Marys Kraft Corporation is now located. In those early days the name applied to that stream was "Pagan's Creek" (then used by heathen Indians), but the spelling of that name is sometimes deceptive, as in the applicant of Catharine Mulleyne for 500 acres "on Pegging Creek". Soon after the grant of 3,850 acres, on "Butter Milk Bluff", was made to Charles & Jeramyn Wright, the name of the stream was changed to Wright's Creek, but strange to say, the plantation that they opened up in the present "Borell", was given the name "Pagan's Creek Plantation". It should be remembered that "Butter Milk Bluff" was the name then applied to what is now the southern end of the present St. Marys, on the St. Marys River; that being the first name that has been found.

The present Point Peter, east of St. Marys, may have been known to the Spaniards as Punto San Pedro, for the creek there is shown on some early surveys as "Saint Peter's Creek", but no other evidence has been found.

When applications for land grants were being made, Point Peter is mentioned as "Wallies", and "Wally's Point"; that being the English pronunciation, and the phonetic spelling, of the name "Guale". The reason for that name ever being applied to Point Peter, can only be guessed. When the Guale Indians, who occupied the Georgia coast north of the Satilla River, were driven south, to seek the protection of the Spanish, many settled on Amelia Island, and the Indian church there known as "Santa Maria de Sena"; became "Santa Maria de Guale".<sup>2</sup>

It seems probable that some of those Indians settled on Point Peter, which would account for the name becoming fastened to that point.

Point Peter, then as now, extended as far north as King's Bay, and extending west from that point, probably at least as far as the present Santa Maria State Park, was known in those Colonial days as "West Shore", or "Weston Shore".

One time we find "Western Shore called the Beach", which must have referred to Kings Bay.
