our Saviour Jesus Christ whose Religion I have
Professed and as I humbly trust - enjoyed
for 18 or 20 Years

Item Second I desire and direct that all
my just debts be paid without delay
By Executors herein after named and I
am unwilling my Creditors should be
Delayed of their rights especially as there
is no necessity for delay -

Item Third I give and devise to my beloved
Wife Matilda with Whom I have
lived in the strictest quiet and love
for Twenty Seven years, Personal and
Real estate with all the rights members
and appurtenances in any way appertaining
or belonging free from charge or limitation

Whatever to her own proper use & benefit and
 Behoof forever with full power to dispose
 of the Same at any time before or at his
 Death as She may think proper
 Item fourth Then and after that time I
 desire and direct That an equal division
 of all That may be both Real and personal
 be made between my bodily heirs:
 Item fifth I constitute and appoint my beloved
 Wife Matilda Executrix and my worthy Sons
 G W Cheesler and John Cheesler executors to the
 my last Will and Testament
