in the first Dist. of Campbell formerly Carroll
during her widow hood and when her death
or marriage to be equally distributed
among my children to wit: James Marion
Thomas Salsford, John & Nancy Abernethy
and a daughter whom should it live.

Item 3rd I also give and bequeath to her
my wife Susan the following slaves
to wit: a negro woman and her son

children Elvina (Mary & ... with
the increase, during her widowhood and upon
her death or marriage to be equally distributed
between the above named ...
mine.

Item 4th I likewise give and bequeath
Susan absolutely as her ...
