 to him in hand paid by the said J. H. Davis at and before the sealing and delivery of these
 presents the Receipt whereof is hereby acknowledged the said Wm. & Davis both bargain
 and sell and by these presents doth bargain and sell unto the said J. H. Davis his heirs Executors
 Administrators and assigns twenty acres in the Southwest corner of Lot number one hundred
 and twenty (20) commencing at said corner running west to the Tallapoosa thence
 down said river further through many of to corner thence west to the west line so as to in-
 clude the above named amount of acres with all the rights members and appurtenances thereto
 belonging or in any way appertaining unto him the said John H. Davis his heirs Executors ad-
 ministrators and assigns to him and their own proper use benefit and behoof for ever in full
 simple & without any other the said William & Davis both have to let his hand and
 sell the day and year above written signed sealed and delivered in the presence of
 Gilbert Cole } William & Davis JP

 of these presents doth grant bargain and sell unto the said John P.
 Watson his heirs Executors Administrators and assigns all that tract or lot of Land
 situate lying and being in the fifth District of Carroll County known and
 distinguished in the plain said District by number sixty seven and eighty
 eight being off of the west side of Lot number sixty six of the same district
 containing two thousand nine hundred and ninety acres more or less to have and to hold
 and deliver the premises aforesaid with all the rights members and
 appurtenances to the said John Watson his heirs Executors Administrators
