hundred Dollars to me in hand paid at and before the sealing and delivery of these presents, the Rec-
eipt whereof is hereby acknowledged both granted Bargained sold and bargained and by these pres-
ents dated this day of Bargain sold and conveyed unto the said Sarah Fields Shobams her late
husband George W. Fields and Joseph L. Fields their heirs and assigns All that tract or parcel of
Land situate lying and being in the sixth District and fifth Section now Carroll County and
known in the plan of said District by number 74 having in the same being that part
of said Land lying and being on the East Side of the Sollaprosa and running with the bound-
aries of the same the said Lot or parcel of Land containing one hundred and fifty acres
more or less so bare and to hold said tract or parcel of land unto them the said Sarah
Fields George and Joseph Fields their heirs and assigns together with all and singular
the rights members and appurtenances thereto belonging to the same in anywise apper-
taining to them to their own proper use benefit and behoof for ever in fee simple and
the said John Shobam has for himself his heirs and assigns the said Bargain granthes unto the
said Sarah Fields George and Joseph Fields their heirs and assigns will warrant
and forsake defend the right and title thereof against any person or any other person lawfully
claiming the same in the County whereof I have hereunto set my hand and affix my
