I give and bequeath and devise to my beloved Wife Nancy Susannah
fraction of Lot of land No 304 in the 6th Dist. of Carroll County with
all the rights appurtenances and appertinances to said fraction
of Land in any wise belonging free from all charge and li-
gation whatever together with the balance of my effects both
real and personal to her own proper use and behoof for
ev. with full power to dispose of the same by will or other wise as she
may deem proper this June the 20 1871 A.M. Golden
