 last Will and Testament hereby revoking all former wills by me made
 I hereby appoint Elbridge G Cabanis Executor of this my last Will
 and Testament and I hereby direct that said Elbridge G Cabanis
 Executor as aforesaid hold the House and a lot in Forsyth on which
 the said James Anthony & myself now reside in Trust for and for
 the use of my son John M. Gordon and his wife to be used & occupied
 by them or the rent thereof to be received by them during their lives
 and at their death or the death or marriage of the wife of said John
 M. Gordon if she should survive him then said house & lot
 to go to & be vested in the Children of said John M. Gordon
 And I furthermore direct that said Elbridge G Cabanis Executor
 as aforesaid hold all my personal property consisting of Household
 furniture wearing clothes and a negro man by the name of
 Amos in trust for and for the use of my son David A. Gordon
 and his wife to be used by them or the hire thereof during his life
 and if his wife survive him or the use of her during her widowhood
 after which to be vested in his Children

Should it appear at any time that a manifest advantage
 to the parties interested by or in this Will can be made by conversion
 of the same into money or other good property, I hereby authorize
 my Executor to make such conversion in trust as aforesaid
 In witness whereof I have hereunto set my hand & affixed my Seal
 this 4th day of April 1848.

Carroll County } State and County being of sound mind and advanced
age and believing I must shortly depart this life deem it right and proper
both as respects my family and myself that I should make a distribution
of the property which which a kind Providence has blessed me, and do
therefore make this my last Will and Testament, hereby revoking all others
heretofore made.

Item 1st I will and direct that my body be buried in a decent and
Christianlike manner suitable to my condition and circumstances
in life.

Item 2nd I desire and direct that all my just debts be paid
without delay by my Executor herein after appointed.

Item 3rd I will and bequeath to my son Elijah M. Woodley
my negro boy Sam about seven years old, which I consider worth
seven hundred and fifty dollars.

Item 4th I will and bequeath to my daughter Sophronia M. Woodley
my negro Girl Mary about six years old with the increase of said
negro Girl the same all to be used remain the sole property of said
Sophronia M. Woodley her lifetime and at her death to the heirs of
her body. This negro Girl Mary I consider worth six hundred dollars.

Item 5th

I will and bequeath to my daughter Surany M. Woodley my negro
Girl Eliza about twelve years old which I consider worth eight hundred
and fifty dollars the said negro Eliza and her increase to be and remain
the sole property of my said daughter Surany M. Woodley her lifetime and
at her death to go to the heirs of her body.

Item 6th I will and bequeath to my son George M. Woodley my negro
boy Charles about ten years old which I consider worth eight
hundred dollars.

Item 7th I will and bequeath to my daughter Martha M. Woodley
and Lucinda M. Woodley each the sum of eight hundred fifty dollars
in cash to be made out of the remainder of my estate.

Item 8th I will and direct that my son Elijah M. Woodley & daughter
Sophronia M. Woodley & my son George M. Woodley each have a sum
of money in cash out of the proceeds of my estate enough to make their
several shares equal to eight hundred fifty dollars according
to the price I have herein placed upon the several negroes bequeathed
them.

Item 9th I will and direct that my Executor herein after appointed
