

Georgia Carroll & I, B.M. Smith of said State & County being of sound mind and disposing mind and memory do make this my last will and testament - Item first It is my desire and I herein direct that after death my remains be interred at home in a decent & christianlike manner suitable to my condition & circumstances in life.

Item second I give bequeath and devise to my wife H. A. Smith the following property to wit - a certain parcel or tract of land being and lying in the 6th Dist of said County the same being on the west side of the road running south from the La Pacific Depot at Villa Rica Ga and being on land lot No (160) one hundred & sixty in said district free from all charge or limitation whatever, to her own proper use benefit and behoof, during her natural life, or widowhood & in the event that my said wife H. A. Smith should marry again, then in that event, the aforesaid property to be sold & the proceeds of the same be equally divided among my bodily heirs, I also, in the event, the residence now standing on the above described property should be destroyed by fire or otherwise, give & bequeath & devise to my said wife H. A. Smith one house & lot in the town of Villa Rica Ga, known as the Portlock house and lot, said property to be held during life or widowhood, after which disposed of as directed of the property first described.

Item 3^d

I herein direct that all the rents of my several houses & lots in the town of Villa Rica Ga be reserved for the education of my children and I herein appoint H. J. Camp as trustee to see to the renting & repairing of said houses & lots, to receive the rent of the same & to see to paying out the same for educational purposes as aforesaid and if there should be a surplus of the rent after paying for repair & the reasonable compensation of the said H. J. Camp for performing the aforesaid duties, the same to be paid over to my wife H. A. Smith for the benefit of my family

Item 4th

I herein direct that all my property, except that described above, be & remain for the proper use & benefit of my family until my youngest child arrives at majority at which time said property is to be sold & the proceeds of the same to be equally distributed among my bodily heirs, but in the event my youngest child should marry before majority, then at the majority of my next youngest unmarried child, the aforesaid property to be sold and distributed as aforesaid.

Item 5th

Now should my said wife H. A. Smith ever during life, claim for herself, the amount of four hundred dollars, then in that event, I herein direct that she said H. A. Smith, shall have no other interest whatever in my said property, but in the event she does not make the aforesaid claim, she shall share equally with my bodily heirs. I herein direct, that if my property should be sold before the majority of my children,

either of them according to the foregoing directions, the proceeds of the same shall be deposited in the bank for the benefit of my minor children, I also, direct that in case there is any notes or debts, unpaid at my death, the same shall be collected & paid to my wife, N A Smith, for the use & benefit of my family

Item 6th

I hereby constitute and appoint my friends W H Pope & H A Pritchett executors of this my last will and testament
