

Letter of Thanksgiving 3. In the morning I wrote
 a short letter to my Father & Mother in
 London expressing my warmest regards to them and saying
 for this life I am a sinner and perfectly unworthy. I
 am daily & hourly that I should make a deeper
 reliance on the rich and abundant mercies of God
 who has made me what I am and who has made
 all other mercies made by me.

I desire and direct that my body be Buried in a decent & Christianlike manner suitable to my Cir. circumstances and
 that in life my soul & trust shall return to God wher-
 at I hope for eternal Salvation through the merits and
 atonement of the blessed Lord and Saviour Jesus Christ
 whose Religion I have professed and as I think
 have enjoyed for several years

I desire and direct that all my Just debts be paid without delay by my Executors hereafter appointed and I am unwilling that my creditors should be delayed in their rights especially as there is no security for them.

I have bequeath and devise to my son Joseph Carr at my death all that Tract or parcel of land containing Sixty Three Acres & 1/200 lying on the Chatahochee River in the County of Wilcox & State of Georgia

Where Boguete and Swine to my son A. W. S. born in the
 location of land containing an hundred & Eighty seven
 Acres No 138 lying on the Ottahecher River in the front
 of said County

Dear August & Maria to my dear John & Carr at my
 dear old friend of Col. of Contingency. One hundred
 dollars & 75 cents. No. 100 being on the whole the same
 the fourth sixth of said quantity.
