remainder is to be the right and property of  
William W. Denomy for and in consideration  
of which he is to support and take care of  
my wife Nancy Denomy for me during her  
natural life, also to take care of and support  
my daughter Rhoda A. Stephens and when the  
above obligation is fully complied with all  
of the property of John Denomy shall be  
the right of William W. Denomy, John Denomy

Denomy in his last will and testament in the  
presence of us the subscribers, who subscribe  
our names hereunto in the presence of said testator  
at his instance and request and of each  
other be signing in our presence we signing  
in his presence.

education and maintenance of my children during  
their natural life or widowhood only, I also give  
and bequeath to my beloved wife in the same  
unreserved manner all my live stock, and farming  
utensils used on and belonging to said plantation  
of every description also my household and kitchen  
furniture I also desire and direct that my executors  
have full power to sell any part or all of my  
land or personal property either for the  
entertainment of my children or to reinvest in
