depart this life deem it right and proper both as respects
my family and myself that I should make a disposition
of the property with which a kind Providence has blessed
me I do therefore make this my last will and testament
hereby revoking and annulling all others by me heretofore
made

First - I desire and direct that my body be buried in a
decent and christianlike manner suitable to my circum-
stances and condition in life. My soul I trust shall
return to rest with God who gave it as I hope for salva-
tion through the merits and atonement of the blessed Lord
and saviour Jesus Christ

Secondly - I desire and direct that all my just debts
be paid without delay by my Executors herein after
named and appointed

Thirdly - I give bequeath and devise to my beloved wife
Frances Elvira - lot of land to one hundred and nine
six in the tenth district of Carroll County the place
upon which I now reside containing two and a half
acres and also two and a half acres of the half lot now
owned by R H Russell lay in south of my dwell-
with all the rights members and appurtenances to
said land in any wise belonging free from all
charge and and limitation whatever to her own proper
use benefit and behoof during her natural life or
widowhood - I also give and bequeath to my beloved
wife in the same unreserved manner the former
intercils ¹⁶ used on and belonging to said farm or used at

the farm so begreathed- And my mule two cows
 and one calf one sow and pigs four pork hogs
 and all my household and kitchen furniture
 and my Blacksmith tools my buggy and two
 horse wagon all without limitation or reserve
 Fourthly- The residue of my property both real
 and personal wherever and whatever it may be in-
 cluding that given to my wife Francis Elmira in the
 third article of this will for and during her natural life
 or widowhood after her estate therein is over- I desire
 and direct that my Executors herein after appointed shall
 sell all real and personal property belonging to said
 estate at public auction to the highest bidder and the
 proceeds to be equally divided between all my children
 except my son James R Long and I will and direct
 that his part be paid to his two children Dolpheus
 and Larissa M Long- I appoint my son F M Long
 guardian of the property of said minor children
 I also will and direct that in the settlement with
 said minors or their guardian that the amount be
 deducted from them part that may have to be paid
 to R H Russell on a note on which I am security
 for their father James R Long.

I hereby constitute and
 appoint my two sons F M Long and Samuel Long
 Executors of this my last will and testament-
