My worldly estate I dispose of as follows:

Item 1st — To my five minor children

William M. Driskill, Sarah S. Driskill, Eugenie
M. Driskill. I give and bequeath all my proper-
ty both real and personal.

Item second — The Real Estate mentioned in said
first consists of the following tracts to wit: Lot of
David No. 258 in the 6th District and 5th section
of said County of Carroll and State of Georgia
and also Thirty seven and 5/8 acres more or
less of Lot No. 192 in said District and coun-
ty, also two town lots in the town of Villa Rica
in said County, Nos. 18 & 20 in the plan or said to-
gether with the improvements thereon

Item 3rd — I do hereby appoint James H. Hines
of the County of Paulding, Executor of this my
last will and testament with full power to
manage and control the same, at his discretion

for the benefit of my said minor children, without requiring
any bond of him my said Executor whatever, and I do
hereby appoint the said James Stoney Guardian of the
person and property of my said minor children.

Item 4th - Should there remain any of the aforesaid
property after my said minor children are raised
and Educated, the said remainder to be their own
and that of the heirs of their own bodies.

Item 5th - The above mentioned property to be equally di-
vided between my said minor children, share and share
alike, and in the event, any one of said children
should die a minor, their share to be equally di-
vided between the survivors of said children.

Item 6th - My said Executor is hereby authorized to
sell or dispose of any of the aforesaid property
as he may see proper for the benefit of my said
minor children, without applying to any Court for
orders to do the same.
