Rebecca Lloyd of Savannah widow, being sick and weak, but of sound mind Memory and Understanding, do make and declare this to be my last will and Testament in manner and form following, That is to say: after payment of my just debts and funeral charges, I give and bequeath unto my Daughter called Reputed and known by the name of Rebecca Lloyd, all my Cloaths and wearing Apparel of what kind or Quality soever, as also my Gold watch, Rings and Jewels and precious Stones, to and for her own use and Benefit: Item, I give, devise and bequeath unto my said Daughter Rebecca, and my Sons Benjamin and Edward, called Reputed and known by the name of Lloyd aforesaid, all and singular my Lands, Lots, Houses & Improvements, and other real Estate, and also all my Negroes, Monies, debts, and other Effects, that may be deemed Personal Estate, wheresoever the same may be found, Situate lying or being, or that may be come at by Suit, at Law or Equity: To Have and to hold the said Lands, Lots, Houses, and Improvements, and other real Estate, and also the Negroes, Monies debts, and other Effects, that may be deemed Personal Estate, unto the said Rebecca, Benjamin, & Edward, called and reputed by the name of Lloyd as aforesaid, and their and each and every of their Heirs, Exors, Admors and Assigns for ever, to be divided among and Between them, in equal parts, Shares and proportions, immediately after my death, so that each child have an equal part, and to be divided at their discretion; And I do hereby revoke any former will by me made, and do hereby nominate and appoint my said Children, Rebecca, Benjamin, and Edward, called Lloyd as aforesaid, to be Executors and Executors of this my Last will and Testament: In Witness whereof I the said Rebecca Lloyd, have hereunto set my hand and Seal, this thirteenth day of April in the Year of our Lord One thousand seven hundred and seventy eight.
