issue and here are unto her and
to the heirs of her Body lawfully
begotten for ever. I also
give and give and bequeath
unto my Daughter Margaret
I had all my flock of cattle
and Hogs of which I shall
die possessed to hold the same
together with their future
issue and here are to her and

to the heirs of her Body lawfully
begotten for ever And also money
and household furniture, all move-
-ables And I do hereby nominate
and appoint my good friends
Frederick Thentler and John Harley
of Savannah in the State afore-
said executors of this my last
Will and Testament hereby revok-
-ing and making void all
former Wills by me at any time
heretofore made In Witness
whereof I the said Catherine Shad
have hereunto set my hand &
seal the fourth day of September
in the Year of our Lord One thousand
seven hundred and twenty eight
