ment into the woods belonging and
also all those seen to graze
Slaves known by the names of
Mintola, Kate, Nancy, Maria
Dale, Sealey and Monday together
with the future issue and
increase of the female slaves
to her and theirs for ever -

Item I give devise and bequeath
unto my said beloved Wife Mary
Wiggins all my flock of cattle of
which I am possessed to her &
her heirs for ever -

Item I give and bequeath
unto my said beloved Wife
Mary Wiggins all the residue

and remainder of my Estate both
real and personal whencesoever it
may be, which I am now possessed
of, or may be entitled to, to her
and her heirs for ever -

Item I give unto my Brother
John Wiggins All my wearing
apparel which I am now possessed
of at the time of my decease.

Item I give and bequeath unto
my father and each of my
Sisters a Suit of Mourning
each, to be found them by
my Executors - And lastly I do
hereby nominate and appoint my
said wife Mary Wiggins my
Executrix of this my last Will and
Testament hereby revoking all
former Wills and Wills by me
heretofore made In Witness

whereof I have herunto set
my hand and seal this twenty
first day of April in the Year
of our Lord One thousand seven
hundred and eighty nine
