 make this my last Will and Testament
 in manner following after deposing
 the charges of my funeral and
 full payment of all my just
 debts I give and dispose of my
 property real and personal as
 follows I give and bequeath
 to my Nephew James Hallack
 son of my Brother James Hallack
 my Negro called Robin to hold
 to him and to mine the said Negro

17^B Robin, to the said James Gallache
my heirs his heirs and assigns
for ever and I give bequeath
assign and set over to my
said Louisia Gallache Daughter
of my said Brother James Gallache
all that Bond principal and
Interest Money due or to grow
due thereon of Nicholas Hanes
which Bond was given granted
and sealed by the said Hanes
to my late Husband and I have
received take and enjoy the said
Money principal and Interest
to my said said Louisia Gallache
and her heirs and assigns for ever
I give devise and bequeath to
William Miller son of John Miller
and Anna his Wife, both deceased,
my heirs and assigns the
Sum of Six hundred which be

was purchased by my late husband
when he purchased the Lot No 6 City of
Futhering Darby Ward in Savannah
I have said I also have and bequeath
to the said William Miles my Negro
boy Harry and my Negro Girl Dole
to have and to hold the said five acres
lot and the said Negroes Harry and
Dole and the future issue of Dole
to the said William Miles his heirs
and assigns forever. I have
also and bequeath to Jane
Miles daughter of the said
John Miles and Anna his wife
all that eastern moiety or half
part of all that my Town lot
in Savannah known by the
number 2/200 in Frederick
Futhering Darby Ward adjoining
the lot of S. Thacker together

thereon: I also Give and Bequeath
to the said Jane Miles my Negro
Woman Sarah and her children
Samuel and Lucy: To have and to
hold the said Eastern moiety of my
said lot Number 2 with the
Tenement and Improvements thereon
and all Members and appurtenances
thereto appertaining together
with the said Negro Woman
Sarah and her children Lucy and
Samuel and their future issue
to the said Jane Miles her
Heirs and Assigns for ever as her
proper Estate Good & Valuable and
not subject to the sale contract
or disposition of any Husband
the said Jane Miles may
have but always to be at
her own disposal

and do hereby discharge and
acquit my said Brother of and
from the payment of all sums
of money I have paid for him
and goods purchased for him
on this express condition that
he makes no demand against
me or estate but shall give a

Release for all such accounts, he
may set up against my Estate.
Whichever Household Goods, or
furniture wearing appare, Bed
and Table linen, Plate and other
articles, now in use about my
House I think it shall be distributed
to and among my three daugh-
ters Anne Gallaiche Jane Miles and Ann
Elizabeth Mills and William Mills
in such manner as I have by
private Memorandums directed
and in default of such private
Memorandums, then to the said
Anne Gallaiche Jane, Ann Eliza-
beth and William Mills share
and share alike; For the payment
of my Debts and other dues I
do hereby direct and authorize
my Executors herein after.

Wanted to sell at public or private
Sale, for cash or credit, as they
may see fit All that my Town
lot known by the Number 6 on
Chart by the City of Savannah in the
Don of Savannah as aforesaid contain-
ing Sixty feet in front and thirty
feet in depth together with all
the Houses and Buildings thereon
and now occupied by Capt and
Family and I do hereby authorize
the said Executors or the Survivor
of them or either of them to make
good and sufficient Titles for the
said lot and premises to the
purchaser or purchasers thereof
and if sold in credit, take and are
to take a Mortgage on the
premises for the purchase
money and after paying all

demands of a just nature require
my debt out of the money
arising from the sale of the
said Lot and premises I direct
and do hereby give and bequeath
the one half of the balance
of such purchase money to the
Children of my Brother that
shall be living at my death
in equal parts. The other half
of the balance of such purchase
money I do hereby give and
bequeath to the said Jane
William and Ann Elizabeth Miles
or such of them as shall be
living at my death in equal
parts. And as to the residue and
remainder of my estate of
what nature soever I give
and bequeath to my
