being sick in Body, but of a sound & disposing mind & memory do make
to ordain this my last Will & Testament in manner following. Whereas
it was by a certain Indenture of three parts bearing date the twenty fifth
day of March in the Year of our Lord, one thousand seven hundred & thirty
two, and made between the said Peter Kerr of the first part, me the said
Elizabeth Kerr by my then name of Elizabeth Sable of the second part
James P. Myers and Balthasar Shaffer of the third part. Previous and
in order to my marriage with the said Peter Kerr my now husband.—
All the undivided moiety of the real & Personal Estates of my late husband
Abraham Sable are thereby assigned and transferred, and therein recited
to be transferred unto the said James Myers and Balthasar Shaffer, their
Executors, administrators & assigns in manner therein expressed.

In Trust Moveable & Immoveable for the sole and separate use & benefit
of me the said Elizabeth Kerr with full and absolute power from time
to time notwithstanding my Coverture by my last will & Testament
in writing or any writing purporting to be my last will & Testament
and attested by three or more credible witnesses to grant, dispose or
give to such person and persons as I the said Elizabeth should think
fit, as in and by the said Indenture, relation being thereunto had may
more fully appear. — Now in Testimony of the love & affection
which I have and justly bear unto my son John Gable and by virtue
of the power & authority enabling me thereto. — The said Elizabeth
do by this my last will & Testament, by me duly signed, sealed, and
published and declared in the presence of the persons whose names are
underwritten as witnesses thereto, give, devise & bequeath to my said
son John Gable. — All that undivided moiety or half part of all that
Lot of Land situate and being in the City of Savannah in Decker
ward, and known by the number eight, — Also all that other
undivided moiety or half part of all that Lot of Land situate & being in
the said City in Reynolds ward. — And also one hundred & twenty five
acres of Land being part and parcel of a tract of Land said to contain
two hundred and fifty acres, situate & being on Little Opechee in the
County of Chatham, to him, his heirs & assigns forever. —

Item. — I give & bequeath to my said son John Gable a negro
man called or known by the name of Silvia to him his heirs
& assigns forever. —

Item. — I give and bequeath all my wearing apparel to the children
of James Bygones of Savannah aforesaid to be equally divided —

To Amcahy Myers one pair of large Gold Buttons and the biggest
gold ring. - Item - I give & bequeath to Elizabeth Myers
the remainder of my gold rings and one half of the articles in the
Bequest. To Mary Myers I give and bequeath my silver chain. -
and to Elizabeth Myers one cow & calf. -

Item. - all the rest and residue of my real & personal Estate I do
hereby give & devise and bequeath unto my said son John Gable, his
heirs and assigns forever. - And lastly I do hereby constitute and
appoint

Executors of this my last will & Testament, hereby
revoking all former or other wills. - In witness whereof I have
hereunto set my hand & seal the day and year first above written.
