Estate which I am entitled unto out of the Estate
of my said deceased Husband Joseph Day be the
same real or personal of what nature or kind soever
To have and to hold the same Every part
and parcel thereof unto the said Elizabeth Boaz
her heirs & assigns forever. —

And I do by these presents make known
Declare my acceptance of a moiety of the Estate of
the said Joseph Day my late Husband under
the

the Constitution & Laws of the state of Georgia, in pre-
ference to my Power, and that the same, & every part
thereof, is the Estate herein before mentioned & intended
to be devised & bequeathed unto my said Mother the
said Elizabeth Box. —

Item. I give devise & bequeath unto my said loving & affecti-
onate Mother, My negro woman Named Sylvia & her
three children, Amelia a mulatto girl, Prince & Tubby,
a black boy & girl together with the future issue
& increase of the females, To have & to hold the
said negro woman Sylvia & her ^{three} children,
Amelia Prince & Tubby, with the future issue &
increase of the females unto the said Elizabeth ^{Box}, her
heirs & assigns forever — — —

Item. I give devise & bequeath unto my said loving
& affectionate Mother Elizabeth Box all the
rest, & residue, & remainder of my Estate both real &
personal of what nature or kind soever or whereso-
ever situate lying or being, to her the said Eliza-
beth Box her heirs & assigns forever.

And lastly I do hereby nominate my said loving
& affectionate Mother the said Elizabeth Box sole
Executor of this my last Will & Testament, —
hereby revoking, all former Wills or Wills
by me at any time heretofore made and ^{this} section

and this only to be contain my last Will & Testament. In Witness whereof I the said Sarah Mary Day have to this my last Will & Testament wrote upon one Sheet of paper subscribed my name & affixed my Seal at Harok in the County of Chatham this Sixth day of July in the Year of our Lord one thousand Seven hundred Ninety seven.
