In the name of God Amen. This is the last will & testament, published and declared, of Elizabeth Davis of Chatham County, widow & relict of Rezin Davis, late of said County deceased.

Item 1st I commit my body to the Earth, recommend my soul to God hoping for salvation through Jesus Christ my Lord & Saviour.

Item 2^d I recommend my body to be interred in a decent christian-like manner

Item 3^d I give & bequeath unto my daughter Dedmona Pickles, one negro woman named Sarah & one negro girl named Milly, together with her future issue and increase & one negro boy named Peter to her and her heirs for ever, and to her sole and separate use & behoof, not subject or liable in any way whatsoever, to the debts, controul or management of her present husband or any future husband which she may hereafter marry.

Item 4th I give & bequeath to my daughter Cynthia O'Bannon one negro girl named Juno together with her future issue & increase to her & her heirs for ever, to her and their sole, separate, & only use benefit & behoof, not subject nor liable to the debts controul or management of her said husband or any that she may hereafter marry

Item 5th I give & bequeath to my daughter Lucy Caves one negro girl named Jenny, together with her future issue & increase, the said negro girl to be left under the care, controul, & management of the said Dedmona Pickles until called for the said Lucy Caves, to her and her heirs for ever to her and their sole, separate use benefit & behoof not subject to the debts controul or management

of her present or any future husband.

Item 6th All the trust & residue of my property whether real or personal I give & devise & bequeath unto my three daughters Desdemona Pickles, Cynthia O'Donnell & Lucy Caves to them and their heirs for ever, share & share alike, upon the same trust & conditions as above expressed. In witness whereof I have hereunto set my hand & seal this thirteenth day of August one thousand eight hundred & sixteen.
