In the name of God, Amen!

This is the last will and Testament of me Sarah Jones, widow of the late Doctor N. W. Jones, my debts and funeral expences being paid, and having by various gifts, donations and acts of affection more or less contributed to the welfare of my family and being possessed of divers negro slaves at present seven in number who may increase before my death I do hereby give devise and bequeath such negro slaves & their issue as follows. It is my will that the said negroes be fairly appraised and divided amongst my grand daughters, Margaret Hunter, Sarah Bulloch, Ann Bourke, Catharine Jones Grimes, Mary Milnor & Charlotte Glen, daughters of my late daughter Sarah Glen and to my granddaughter Sarah Jones, daughter of my son Doctr. George Jones in equal value and if possible in number, but should any difficulty occur as to this mode of division, such of my Executors as may qualify may sell the said negroes and every one of them and divide the money amongst my said granddaughters above named as also to sell my riding Carriage and apply the money as above Reserving however out of such value or sales of negroes & carriage two hundred dollars to be paid, over and above her share to my granddaughter Charlotte Glen she being the youngest, requiring education, and least provided for, the money or negroes not be subject to any debts, or the controul of the husbands of my grand daughters, but subject to their and each of their application, as if single women. For her faithful and long services after severe trials and conflicts I do after my death, discharge from any servitude my old negro woman Rachael and recommend her to the care of my family. — Altho' I have not mentioned my grandsons on this occasion, because I have before been attentive to them yet they will not suppose that because their sisters are only mentioned I have no regard for them, not so. my affection for them is equal. They are men — many may be provided for — all capable under providence to ad

grandson George Glen, my friends Barack Gibbons & William
Stephens my executors and trustees to carry this will into
immediate effect after my funeral and circumstances

I give to my granddaughter Charlotte Glen my mahogany bedstead, half dozen new dessert spoons and one pair of new rose Blankets. I give to my granddaughter Mrs. Sarah Bullock my gold watch & chains belonging thereto.
