 erine, Eleanor, Sarah Ann & Christopher shall have divi-
 ded, each his proportion of whatever property there may be
 each equally to share alike, to have & to hold the same dur-
 ing their lives, and at the event of their deaths that their
 lawful heirs shall have and hold the same with equal

thoughts and wishes — and to request you to carry them
into complete execution, as my last will and to consider
this document as my private, nuncupative & auto-graph-
ical Testament.

shall be consigned to the mansions of rest you

the causes which produced the untimely fate of your
illegitimate son, and desirous myself that you
should neither form distressing conjectures nor
live in painful incertitude about the real cause
of my death, I feel constrained to reveal to you what
I had never intended to communicate to any body
in this world. Know then that the wife of Flem-
ing Freeman was the sole cause of my premature
death.
