making null and void all and every other will or wills
by me at any time made - and more especially a certain
will or Testamentary paper by me executed bearing date
the nineteenth day of November in the year of our Lord
one thousand eight hundred and forty six in the presence
of Alexander M. Shaw and Hickliff Brown Notary Public

1st It is my will and desire that all my just debts and funeral
expenses be first paid out of my estate hereinafter mentioned
and describes - 2nd I give devise and bequeath unto my son
John M. Palin of the State and County aforesaid & to his heirs
forever, all that moiety of that Lot of Lands with the build-
ings and improvements thereon situate lying & being in the City
of Savannah Warren Ward, and known and distinguished in
the plan of said City by the Number 101/51thly subject to
the payment of an annual ground rent to the Corporation
of the City of Savannah and bounded on the North by a
Lane on the South by Bryan Street on the West by Lot of John
McNish and on the East by Dr. William Parkers Lot, convey-
ed to me by a Deed of bargain and sale from Abraham
Dalyon and Isaac Rufus trustees; together with all other
real estate wheresoever situate of which I may die seized &
possessed - 3rd I give and bequeath unto my said son John
M. Palin all the personal Estate of which I may die possessed
of whatsoever nature or kind the same may be or wheresoever
situate To have and to hold to him his heirs and assigns
forever - I hereby nominate constitute and appoint
my said son John M. Palin sole Executor of this my last
will & Testament - In witness whereof I have hereunto
set my hand and seal, this twenty second day of June
in the year of our Lord one thousand eight hundred &
forty six - Signed sealed published and declared by
