In the name of God Amen I Joseph Bryan of the Parish of Christ Church in the Province of Georgia Gentleman, although sick and weak of body yet being of sound and disposing mind and memory and understanding, calling to mind the uncertainty of life, do make and publish this my last will and testament in manner and form following that is to say First I desire that all my just debts and funeral expences be paid and discharged with all convenient speed as soon as may be after my decease, and such Estate as I may be possessed of I give devise and bequeath in manner and form following that is to say unto my beloved wife Elizabeth Bryan her heirs Executors administrators and assigns forever, I give devise and bequeath the one fourth part of the negroes monies goods Chattels and other personal Estate that I may die possessed of after the payment of my said debt and funeral expences, I also further give devise and bequeath to my said beloved wife Elizabeth and to her heirs and assigns to and for her and their only proper use and behoof forever all that my tract of four hundred and fifty acres of land known by the name of Davis tract situate on the Island of Wilmington in the Parish of Christ Church in the Province aforesaid together with the rights members and appurtenances thereunto belonging and appertaining and my will and intention is that the several bequests and devise above made to my said wife are upon this express Condition that she do accept of the same and she do declare my Gift thereof to be in full discharge of all dower and thirds or other Claims that she may or can after decease lawfully make upon any part of my Estate or I otherwise revoke and annul the several bequests before made to my said wife and declare the same and every part thereof void Item I give devise and bequeath to my son Joseph Bryan the use of the remaining three fourths of all my negroes to work and employ the same to the best advantage and to receive and enjoy the profits and emoluments arising and to arise from their labors and services for and during the term of his natural life and in case he shall die having lawful heirs of his Body then I give and devise all the said negroes and their increase unto the heirs or heirs of the Body of my said son his her or their Executors administrators and assigns forever. I also give devise and bequeath unto my said son Joseph Bryan and his heirs for and during the term of his natural life the occupation possession and enjoyment of all and every my plantations other tracts of land and real Estate whatsoever or wheredever the same may be situate that I may die possessed of or be entitled unto

by any and all persons with full power to receive
 and take the rents issues and profits thereof and of every part
 thereof and to plant sooth improve clear or otherwise manage
 the same during the term of his natural life as aforesaid and
 in case he shall die having lawful heirs of his Body then I
 give and devise all the real Estate aforesaid to the heir or
 heirs of the body of my said son his heir or their heirs and
 assigns forever in fee simple, and in case my said son Joseph
 shall depart this life without issue or lawfull heirs of his Body
 then immediately from and after his decease my will and desire
 is that my said Executors or the survivor of them or the Executor
 or administrators of such survivor shall and I do hereby fully
 and absolutely authorize and empower them or either or any
 of them respectively to take and receive into their or some one
 of their Custody and possession the said three fourths of my
 negroes and their increase and also the said real Estate, to sell
 and dispose of and make and execute good and sufficient
 Emphyances and assurances in fee simple of my said real
 Estate and absolute Bill or Bills of sale and assurances of
 my said personal Estate as my said Executors or the survivor
 of them the Executors or administrators of such survivor shall
 think for the best advantage, and the neat proceeds arising
 from the sale of my said real and personal Estate I give de-
 vise and bequeath unto my Brother Hugh Bryan and William
 Bryan and my sister Hannah Bryan, their heirs Executors
 administrators and assigns respectively forever share and
 share alike. Item I give and bequeath to my honoured father
 and all other a suit of mourning each as also a suit of mourn-
 ing unto each of my Brothers and Sisters I also give to Mr. Clayton
 Smith my dear & old mourning ring in token of the esteem
 I had for him, I also give unto my friend Mr. Thomas Landon of
 Johns Island in South Carolina a gold mourning ring -
 I also do in Consideration of the many faithful services per-
 formed me by my negro slave Peter thereby manumit and set
 him free of and from all manner of slavery and servitude what-
 soever immediately from and after my decease forever, and
 also all the rest and residue of my Estate not herein before dis-
 posed, of what nature kind or quality soever, I give and bequeath
 unto my said son during life and the heirs of his Body if he
 shall have any heirs and in default of such heirs, I give & bequeath
 the said residue of my estate to my Brothers Hugh Bryan and
 William Bryan and my sister Bryan their heirs Executors and

ministers of the Gospel to be equally divided between the
 share and share alike, and I do hereby revoke all former wills by me at any time
 heretofore made and declare this only to be my last will and testament and
 I nominate and appoint my said Brother William Bryan Guardians and
 in case of his decease Edward Telfair Esq and William Gibbons (Senior)
 Guardians over the person and Estate of my said son Joseph Bryan
 until he shall arrive to the age of fifteen years and I do hereby
 nominate and appoint my said Brother William Bryan and Mr
 William Gibbons of Savannah Merchant Executor of this my will
 recommending to them to divide my Estate with all speed and to the
 Guardian of my son to improve the Estate bequeathed to him In witness
 whereof I have to this my last will and testament contained in four
 pages of one sheet of paper set my hand and seal this twenty eighth
 day of November in the year of our Lord One thousand seven hun-
 dred and seventy four
