

In the name of God Amen I James Josiah Tiffin of Chatham
in the State of Georgia being sick and weak in body but of sound and
disposing mind do make this my last will and testament in witness
following: I devise and bequeath to my sister Rebecca Margaret
Thompson of South Carolina my two negro men named Prince
and Harry for and during the term of her natural life for her
separate and exclusive use; and from and after the death of my
said sister I give the said two negro men to her Children to be equally
divided between them, as is directed in relation to my other Slaves
herein after named to the Children of my said sister their executors
administrators and assigns I give devise and bequeath
to the Children of my said sister Rebecca Margaret Thompson all
my other negro Slaves named Monday, Doctor, Tom, Henry, Jack, John
Hagar, Charlotte, Christiana Pittu, Peggy and William with the
future issue of the females; to them their executors administrators
and assigns; to be equally divided between them the said Children
share and share alike. It is my will and desire the several
negro Slaves last named be allowed to work out by executors and
the proceeds of their labour applied to the education and support
of the Children of said sister if it should be necessary; and if not
that it be put out at Interest from time to time for their benefit;
and as some of my Slaves above named have families in this state
it is my wish and desire that these be allowed to remain in this
State so that they should not be separated from their wives and
husbands. And I do hereby nominate and appoint Isaac Allmer
and Paul Allmer of South Carolina and Thomas Asher of Chatham
to be the Executors of this my last will and testament. In witness
whereof I have hereunto set my hand this fifth day of a November
in the year of our Lord One thousand eight hundred and twenty
six.

In the name of God Amen, I John W. Dumas of the Island of Miltonington in the County and State aforesaid being in good health of body and of sound and disposing mind and memory but knowing the uncertainty of human life and being desirous to settle my worldly affairs whilst I have strength and capacity to do so, do make and publish this my last will and testament hereby revoking and making void all former wills by me made: First my Will and desire that all my just debts and funeral expences be paid as soon after my decease as conveniently may be: Item it is my will and desire that from and after the payment thereof and subject thereto, all the residue of my real estate and slaves be undivided and undisposed of until my daughters or one of them shall marry or attain the age of twenty years, upon either of which events I desire and direct that my estate do
