In the Name of God Amen, I Margaret Watley of Savannah in the County of Chatham and State aforesaid do make and declare this my last Will and Testament in manner and form following, that is to say, I give, devise and bequeath unto my son in Law Alonzo C Shaw all that lot in the City of Savannah Green Ward and known on the plan of said City by the number Thirty Seven; also my two Negro Slaves Henry and Mary, and furthermore I do give, devise, bequeath & relinquish to my said son Alonzo C Shaw all my right title claim or interest in or to the following negro slaves namely, Sarah, Ishmael, Charles, and Moses, also being entitled to ten dollars in the contemplated and last Pottery I do give and bequeath the same together with all the afore named property Real and personal unto the said Alonzo C Shaw his heirs, executors, administrators and assigns forever. And I do constitute and appoint the said Alonzo C Shaw sole executor to this my last will and Testament.

In witness whereof I have hereunto set my hand and seal this Twenty and sixth day of March and in the year of our Lord One thousand Eight hundred and twenty six.
