

The last will and testament of Michael Fisher of the District
of White Bluff in the County of Chatham and State of Georgia
Planter

Michael Fisher being weak in body, but of sound-
mind and memory blessed be Almighty God do make and
publish this my last will and testament that is to say

First I give devise and bequeath to Albert & Dennis and Mary Ann
Elijah Dennis all my right and claim to an undivided third
part of the tract of land whereon I now reside, and also of two
negroes named Hector and Thora which I acquired in virtue
of my intermarriage with their mother, my late beloved wife.
Also I give to them the said Albert & Dennis and Mary Ann
Elijah Dennis all the right and title I may have to the home
hold furniture which was possessed by their mother at the
time of my intermarriage with her. Also I give release ac-
quit and discharge them the saids Albert and Mary Ann
Elijah Dennis and their estates from any charges I may have
against them for support provided that no claims be set up
by them or their guardians against me or my Estate for their
proportion of the proceeds of the property in my possession held joint
by them and me.

Item I give devise and bequeath to my beloved son George David
Henry an undivided third part of a tract of land in Dooly
County in the state of Georgia a bush shears and little live estate
of my intermarriage with his mother my late beloved wife, and
also I give, devise and bequeath to my said son George David
Henry all the rest, residue and remainder of my Estate real
and personal, debt, goods and chattels of what kind and nature
soever. I do hereby direct my executors to be herein after named
to sell and dispose off as soon after my death as they may deem
expedient either at public or private sale according to their best
judgment all my household furniture horses, gigs, carts, plantations
tools except such as may be required on the plantation, and all
my personal estate except my negroes and appropriate the proceeds
of such sale to the payment of my just debts and I do also further
direct my said executors to use diligence to collect all debts of what
ever nature they may be that are due to me. I do also appoint my
said executors the guardians of my son George David Henry un-
til he arrive at the age of fourteen years and until other guardians
be legally appointed.

Lastly I do hereby appoint my sons Albert & Dennis

testament hereby revoking all former wills by me made. In witness whereof
the said Michael Fisher have hereunto set my hand and seal this twenty-fourth
day of March in the year of our Lord one thousand eight hundred and forty,
A.D. 1827.

other. The word "from" in the twenty-first line of first page and "or private"
in the eighth line of second page being first intended.

as witnesses to the due execution of the said last will and testament
at the request of the testator in his presence and in the presence
of each other.
