

This is my last will, made at New Ark N.C. this sixteenth day of September 1826 that in case any accident by death should hap-
 pen to the undersigned That he bequeath his property in New
 Ark N.C. to say one house and lot in said town fronting
 the upper Common as per deed from Doremus and Ward
 for the use of his father and mother during their lives, or her or her
 life, to have and to hold the same unmolested after both their
 departures (or deaths), the said property shall belong to Abby
 and Eliza Maria Price jointly and shall be by them dis-
 posed of as they shall judge best. and that Three thousand
 and Dollars from sales of other property that I may own after
 paying all my just debts, to be put out at interest on good
 security by mortgage on property. The interest thereof to be applied
 for the benefit and use of my father and mother or either of them
 during their lives after which, said money shall be taken up
 and divided equally between George A Price Abby L Price &
 Eliza M Price for their use forever. I should on settlement of my
 affairs more than three thousand dollars be found or collected
 the surplus to be for the general benefit of the family - this is my
 will and pleasure. This day and date as above. Edward
 Price and William Price I appoint Executors to this will.

Edward Price Coquina one of the Executors in the annexed will named (William Price the other executor therein named having duly renounced according to law) being duly sworn according to law did depose and say that the annexed writing contains the true last will and testament of Thomas R Price late of New Ark in said County of Essex and also late of Savannah in the State of Georgia the Testator therein named as far as he knows and verily believeth and that he will as the Executor thereof will and truly perform the same first by paying the debts of said deceased and then the legacies therein specified as far as the goods Chattels and Credits of said deceased will therunto extend and the law Charge him and that he will exhibit into the surrogate office of the said County of Essex a true and perfect Inventory of all and singular the goods Chattels and Credits of said deceased which have or shall come to his knowledge or possession or to the possession of any other person or persons to his use, and that he will well and truly account where therunto lawfully required and he further says that said Thomas R Price died more than ten days last past as he verily believeth and is informed.
