my worldly affair while I have strength to do - do
make and publish this my last Will and testament
and first I commit my soul to God who gave it, and
my body to be buried in the grave yard at Hoskibbia
Church, and my worldly estate I dispose of as follows
1st I leave all my effects both real and personal
in the hands of my three Sons, viz, R.L. & W.W. & D.L. Purley
whom I appoint my executors to be used for the Sup-
port alone of my wife, my daughter Violet and her
children until the youngest child becomes 15 years
of age, And that my Daughter Martha be provided
for on the premises with her two children as a part
of the family provided she does not go with R.L.
Matthews; All my effects to be subject to the disposal
for the benefit of the family for said term of time
After the expiration of said time if my wife Rebecca
is living she still shall have her Support from
my property But if she is dead the property not dis-
posed of is to be sold by them and equally divided
between the following named Children viz, R.L. &
Purley, Sarah Lodge, W.W. Purley, & J. Purley
Violet R. Purley, Martha & Matthews & Mary Charlton
which are my natural heirs, my other heirs having
received previously more than the above named
will get - My executors are soon after the
Establishing of this my last will to pay out
if my effects all my just debts -

Style of Garcia

Chattanooga County : In the name of God, Amen,
I James Garcia, citizen of said State
and County, being of advanced age; and knowing
that it may shortly depart this life, doemt right
and my son, both as respects my favorite and my-
self, that I Should make a disposition of my property
with which a kind Providence has blessed me, thence-
fore make this my last Will and Testament, hereby
repealing all others heretofore made by me -

Item 1st I desire and direct that my body be
buried in a decent and Christian-like manner suit-
able to my circumstances and condition in life.

My Soul I trust shall return to rest with God who
gave it.

Item 2nd I desire and direct that all my just
debts be paid without delay by my executors hereinafter
appointed, as I am unwilling my creditors should
be delayed in their rights -

Item 3rd I also, remeinder & devise to my beloved
wife, Mary, Lot of Land number 1000 hundred and
fifty six in the Township district a fourth Section
of Chattanooga County, whereon I now live plantation one
hundred acres of which is cleared and in cultivation
about thirty acres with all the rights annexed and
appurtenances to said lot of Land in anywise belonging
free from all charges whatever to her own proper use
benefit and behoof during her life or widowhood.

I also give and bequeath to my beloved wife
in the same manner the farmings & all used on and
belonging to said plantation, with my houses, cattle
and hogs, together with household and kitchen
furniture.

Item 4th I will that at the death of my
beloved wife, Mary, that all my property then left
be equally divided between my three children
